As part of the transition plan, after EI Service Coordinator will ensure that the family is aware of the array of service and program options are available under Part B including home, day care centers, Head Start programs, schools and community-based settings.

The EI Service Coordinator will meet with the family to identify and document the specific steps and actions that will support the child-care needs. These individualized steps and actions are documented on the transition plan and are included in the IFSP.

The El Service Coordinator will fax, email, or mail (using confidentiality assurance) a Transition Referral Form to the SPED Director (or designee) at least 60 days prior to the Transition Conference, and if possible 6 months prior to the child's third birthday.

With parent consent, the EI Service Coordinator will send written invitation to all parties listed in the IFSP (Head Start, NMSBVI, NMSD and childcare providers).

Special Education Directors (or designee) will coordinate efforts with EI providers to support parent and family involvement in the transition process. SPED directors (or designee) will coordinate with EI providers to facilitate visits by families to classrooms and/or learn about services provided by the school district.

SPED directors (or designee) will verify receipt of the Referral Form and Assessment summary form by email to EI Agency.

The LEA will review the information (using the REED process) and materials sent from the EI program in order to determine who will attend. If additional evaluations might be necessary, the SPED director (or designee) should be ready to sign consent for evaluation at the transition conference. NMSBVI

NMSBVI will provide a current Functional Vision Evaluation and Learning Media Assessment for students who are blind or visually impaired, to be used in eligibility determination and programming design.

The Special Education Director (or designee) will conduct the initial evaluation in accordance with 34 CFR§ 300.304 to include a variety of measures and sources, including functional, aptitude, and achievement tests, and parent input, as well as information about the child's physical condition, social or cultural background.

NMSBVI

NMSBVI will participate at the Eligibility Determination Meeting for students who are blind or visually impaired.

Eligibility Determination Meeting

The Special Education Director (or designee) will assure that a group of qualified professionals and the parent of the child determine whether the child is a child with a disability in accordance with state and Federal regulations. With parental request and consent, the EI Service Coordinator or other EI representatives listed on the child's IFSP will be invited to the EDT meeting and/or the IEP.

The Special Education Director (or designee) will determine eligibility for Part B services that includes the review and use of existing Part C evaluations and assessments and the IFSP information as part of the initial evaluation. Tests must have been administered within the previous six

When invited, Head Start will attend the EDT and/or IEP.

When invited, the EI Service Coordinator will attend the EDT and/or IEP.

NMSBVI will provide NMVICount information for students who are blind or visually impaired to the receiving program. The NMVICount is the federal APH census that provides support and educational materials to the district and students through the NM-IRC lending library, such as textbooks (braille, adapted textbooks), enlarged materials, and other adapted materials available from APH (The American Printing House for the Blind). The Special Education Director (or designee) will conduct the initial IEP meeting no later than 15 days prior to the child's entry into the preschool program.

If a child is determined eligible for services through Part B, and parent intends to enroll child in services through a Part B agency, an IEP will be developed 15 days prior to the determined start date.

The Special Education Director (or designee) at the request of the parent must send an invitation to the smooth transition services. The Special Education Director (or designee) will provide a copy of the procedural safeguards to the parents.

In the case of a child with a hearing loss, even if the hearing loss is not the child's primary condition, the Communication Considerations for Children with a Hearing Loss IEP addendum MUST be completed by the IEP team to facilitate discussion around the child's communication needs. NMSD Regional Early Childhood Consultants are available to IEP teams for support and consultation.
